CHANGE OF STOCK SHORT NAME

The Board is pleased to announce that the Change of Name took effect on 27 February 2008 under the laws of Bermuda and the name of the Company has been changed to “Green Global Resources Limited” and the new Chinese name “綠色環球資源有限公司” adopted for identification purposes has become effective on 27 February 2008 and the Certificate of Registration of Change of Name of Oversea Company has been issued by the Hong Kong Registrar of Companies on 2 April 2008.

Following the Change of Name becoming effective, the stock short name for trading in the Shares on the Stock Exchange will be changed from “VENTURE INV” to “GREENGLOBAL RES” in English and from “宏昌投資” to “綠色環球資源” in Chinese with effect from 11 April 2008. The stock code of the Company of “61” will remain unchanged.

CHANGE OF NAME

References are made to the announcement (the “**Announcement**”) of the Company dated 22 January 2008 and the circular (the “**Circular**”) of the Company dated 28 January 2008. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless defined otherwise.

The Board is pleased to announce that the change of name (the “**Change of Name**”) of the Company took effect on 27 February 2008 under the laws of Bermuda and the name of the Company has been changed to “Green Global Resources Limited” and the new Chinese name “綠色環球資源有限公司” adopted for identification purposes has become effective on 27 February 2008.

The special resolution regarding the Change of Name has been duly passed by the Shareholders by way of a show of hands at the SGM. The certificate of incorporation on the Change of Name has been issued by the Registrar of Companies in Bermuda on 4 March 2008. Accordingly, all pre-conditions in respect of the Change of Name have been satisfied and the certificate of Registration of Change of Name of Oversea Company has also been issued by the Hong Kong Registrar of Companies on 2 April 2008.

Effects on change of name

The Change of Name of the Company will not affect any of the rights of the Shareholder and share certificates of the Company will be issued in the new name of the Company in any subsequent issue of shares of the Company after the Change of Name has become effective. However, all existing share certificates in issue bearing the existing name of the Company will continue to be effective as documents of title to and be valid for trading, settlement and registration purposes. There will not be any arrangement for the exchange of the existing share certificates of the Company for new share certificates bearing the new name of the Company.

CHANGE OF STOCK SHORT NAME

Following the Change of Name becoming effective, the stock short name for trading in the Shares on the Stock Exchange will be changed from “VENTURE INV” to “GREENGLOBAL RES” in English and from “宏昌投資” to “綠色環球資源” in Chinese with effect from 11 April 2008. The stock code of the Company of “61” will remain unchanged.
